 - 1. The program was very well attended. The program covered a variety of privacy-related topics: everything from current legislation to library policies to best practices to day-to-day concerns for library users.
 - 2. This is such an important topic for libraries. Computers and Technology Committee Chair James Hutter was very glad of the level of interest and that it was to have Directors in our audience.

 - 1. The committee will be discussing a variety of topics from the listsery, such as the current state of Privacy issues and computing, Microsoft Office for iPad (iOS), and lending Tablets.
 - 2. There will be an open Q&A period during the meeting (a great opportunity to ask troubleshooting/policy questions) and then a tour of the Massapequa Public Library's technology offerings.

h. Health Services – Mahnaz Tehrani (Absent)

- i. Please mark that the HS Committee of NCLA is looking to plan a program on the topic of: "Caring for the Mind: Providing Mental Health Information at Your Library."
 - 1. The committee has contacted Lydia Collins from NN/LM (National Network/Library Medicine) to find out if she is willing to come out for a face-to-face workshop on the subject in hand.
 - 2. The committee would like to have this program early spring March-April depending on the presenter schedule.
 - 3. Here is a brief description for the class:
 - a. Responding to questions involving topics on mental health is challenging even for the most experienced librarian. In *Caring for the Mind*, participants will learn how to effectively provide mental health information at their libraries.
 - b. Participants will learn about the best electronic resources to consult as well as ways to improve their print collections.
 - c. Best approaches for handling interactions with emotional patrons will also be discussed.
 - d. Other topics covered include:
 - i. Bibliotherapy
 - ii. assessment/testing
 - iii. the future of mental health.
 - e. This class will increase participants' skills for providing mental health information for care providers and the public.
 - f. This class will be approved for 1-4 hours MLA CE.

i. Institutional Services – Amrita Madray (Absent/No Report)

j. <u>Intellectual Freedom – Jeffrey Feinsilver</u>

- i. The committee last met on Wednesday, December 17.
- ii. On December 8, the committee held a joint program with the Computers and Technology Committee called, "Privacy @ Risk."
 - 1. 24 people attended the program.
 - 2. A wide range of topics were covered and the discussion could have gone on longer, if time permitted.

- **iii.** The theme of the 11th "Freedom to Read" Essay and Art Contest is as follows: "Pick an Important Action Taken by a Character in a Story or Movie. What would YOU have done? Why?"
 - 1. Elementary students to high school students are able to participate in this contest.
 - 2. Sometimes the committee can receive several hundred responses.
 - 3. The deadline for the contest is April 1.
 - 4. The reception for the contest is planned for May 21 at 7:30PM at the Levittown Public Library.
 - a. Typically, 55-70 people attend the reception.
- **iv.** For the LILC, the Intellectual Freedom's sponsored program will be about issues dealing with censorship of artwork and exhibits in libraries.
 - 1. The Manhasset Public Library was once involved in a court case involving the display of artwork that included nude figures.
- v. The committee's next meeting will be held either January 27 or January 28 at the Merrick Public Library.
- vi. The following news items were discussed:
 - 1. There were obvious threats to intellectual freedom with the Sony Hack and *The Interview* film.
 - 2. There was a recent terrorist attack in France against the Charlie Hebdo Magazine.
- vii. Gmail has been blocked in China since Christmas and has in general been trying to block social media information.
- **viii.** Google, Facebook, and Yahoo have formed a coalition to reform government surveillance, which advocates for limits on national security and more transparency with government requests.
 - ix. The Freedom Act failed to be brought up for debate by two votes in the senate.
 - **x.** It is the sunshine year for the Patriot Act.
 - **xi.** The FCC is supposed to vote on net neutrality in February. Internet providers are against net neutrality.
- xii. Selfies are taking center in debate at the Center for Digital Information.

k. LDA Award - Marcia Olsen

- i. Work has begun on the LDA Award. Suffolk will be printing out flyers this year for the award and hopefully will be sent out by the end of the month.

q. Newsletter - Mamie Eng

- **iii.** Mamie Eng is working on the Year-In-Review issue of the newsletter. Mamie received reports from some divisions, and encouraged those who haven't to submit something.

 - 1. Chris Marra asked if the archived newsletters could have their own separate link or heading that is no longer part of the "About" tab so they are easier to find. President Courtney Greenblatt noted she would discuss this possible change with Lee Gundel.

s. Outreach - Mary Robinson

- i. On December 11, the Outreach Committee hosted an author visit at NLS featuring Marybeth Zeman, author of *Tales of a Jailhouse Librarian:* Challenging the Juvenile Justice System One Book at a Time.
- **ii.** The committee is still working on its content for its section of the NCLA website.
- **iii.** The committee is working on creating a map of Nassau County which highlights where ESL classes are offered.
- iv. The committee is also planning to arrange trips to different agencies within Nassau County, such as Woodward's Children's Center in Freeport, which is designed to help children who have been abused.
- **v.** The next committee meeting will tentatively be held on February 27 at Freeport Memorial Library.

t. Personnel Issues and Professional Concerns - Bobbi Benigno (Absent)

u. Pop Culture – Laura Giunta

- iii. On February 4, 2015 at the Garden City Public Library from 9:30AM-12:00PM the committee will be hosting a Video Game Roundtable Discussion and Demo. During the program, librarians will have the opportunity to demo different consoles/systems.
